





EU funds implementation progress in Poland in 2007–2015









Capacity of 300kg, unrestricted area, no platform controls,









Top 15 construction companies by revenue in m€ in 2016





Safety at height



PIP Labour Office Rapport 2012:

- 61 people killed in construction sector,
- **139** people injured, fallen down form scaffolds
- 34,4% out of dead accidents happened on the construction
- on 55% of controlled sites there were 1299 documented miss installation of scaff

PIP Labour Office Rapport 2013:

- 20 people killed with a fall from scaffold, 16 with a fall from leader
- 1246 scaffolds which were controlled were having miss installation,
- 33,7% in total dead cases happened on construction sites

PIP Labour Office Rapport 2014:

• **15** people killed with a fall from scaffold, **13** with a fall from leader

PIP Labour Office Rapport 2015:

• 8 people killed with a fall from scaffold, 7 with a fall from leader

PIP Labour Office Rapport 2016:

Fall from height – people killed 32,

75% accidents of falls on

construction sites with injuries

were consequences of:

- incorrect training of HSE or no training at all,
- no supervising
- daring behaviour and risk taking,
- management accepting aberrance of HSE regulations
- no personal protection

 My. sygnatariusze niniejszego dokumentu zawieramy porozumienie Głównych Generalnych Wykonawców w Polsce w celu zwiększenia bezpieczeństwa pracy w budownictwie, w szczególności mając na uwadze zapobieganie wypadkom śmiertelnym.

Budownictwo jest obecnie najbardziej niebezpieczną gałęzią gospodarki narodowe, pochłaniając w każdym roku ponad sto oliar śmiertelnych tj. około 25% wszystkich ofiar śmiertelnych związanych z wypadkami przy pracy.

- 2. Porozumienie ma na celu zjednoczenie wysiłków największych firm budowlanych w celu zahamowania wypadkowości przy pracy, wymianie dobrych praktyk, ujednoliceniu podejścia do zagadnień bezpieczeństwa pracy a przede wszystkim oddziatywanie na sferę podwykonawców, średnich i drobnych firm budowlanych, gdzie wypadkowość jest największa.
- Zakładamy, że będziemy działać autonomicznie, tworząc wtasne, niezbędne struktury robocze oraz kierując się ustalonymi przez siebie kryteriami i zasadami. Dekłarujemy także zgromadzenie niezbędnych środków dla realizacji wspólnych celów.

 Nasze porozumienie ma charakter otwarty. Może przystąpić do niego każda, znacząca firma budowlana a głównym warunkiem jest uznanie celu jakim jest nadrzędność bezpieczeństwa pracy we wszelkiej dziatalności gospodarczej.

Zaktadamy także jak najdalej idącą wspótpracę z instytucjami publicznymi i organami państwowymi działającymi w tym samym, co deklarowany przez nas, celu – bezpieczeństwa pracy.






The turnover of PSBW Members in 2015 was 130,3m€ The PSBW does represent ~60% of AWP rental The depot network of PSBW members 141 locations






- Note Aggreko numbers not included


- 2011-2012 Poland was organizer of EURO2012 Football Championships
- 2011 vs. 2015 AWP and telehandlers specialist revenue was +94,5% (rental and machine sales)





Obligations of owners to UDT

- Register machines (fee paid by maximum load capacity)
- Notify about all accidents
- Inspect machines accordingly to service manual or one time a month with UDT certified mechanic
- Owners, users, operators are having criminal responsibility toward technical state of machines

Polish Rental market:


Developing market within high competitive environment and challenges coming form construction market.
